QUALIFICATION FOR MEMBERSHIP

To be eligible for membership a person must be:

- Not less than eighteen years of age. unless applying for Junior membership.
- of good repute and character and compatible with other members.
- Free of indebtedness to any Bowls Club or Bowls Association of which he/she is or may previously have been a member.

CLASSIFICATION AND PRIVILEGES OF MEMBERS

- (1) ORDINARY MEMBERS :- will comprise such members as are entitled to all Club privileges. Only persons interested in playing the game of Bowls shall be eligible for election as an Ordinary Member.
- (2) JUNIOR MEMBERS :- Junior Members shall not be entitled to hold any Office of the Club but may take part in any Inter-Club matches and Club Championships.
- (3) SOCIAL MEMBERS :- Social Members shall be entitled to all Club privileges, except they shall not be entitled to hold any office of the Club nor shall they be entitled to nominate members for election to any position in the Club, nor shall they take part in or vote at meetings of the Club.
They shall not be entitled to nominate ordinary members of the Club. Social members shall only be permitted to participate in the game of bowls by invitation of the branch
